CONDITIONS OF THE SHOW

1. All items being sold at the Cabin Fever Market must be handmade in Ohio.
2. Review, selection and acceptance are performed by a panel. Current artists/vendors of The MarketPlace at Hale Farm and Village are not guaranteed a space.
3. Photos of items to be sold must be submitted with your application for review by the Cabin Fever Market panel. Application and photos can be emailed to jmoretuzzo@wrhs.org.
4. If you are excepted into the show, a booth fee of \$50.00 must be submitted. We accept checks or credit card payments. Checks can be made payable to Hale Farm and Village.
4. All sales will be rung up by the artists at their booth. HFV staff will not be taking payment for items sold at artists booths. It is recommended that vendors bring their own hotspot to ensure internet connection if needed.
5. Vendor/artist tables must be staffed with a vendor representative or artist at all times and are expected to be actively engaged with our guests.
6. The last guest will be admitted into Hale Farm & Village for the show at 4:00pm. Once the guests are done shopping, a Hale Farm and Village staff member will give you the go ahead to start packing up your booth. Booths are not to be packed up before this time.
7. One eight (8) foot table and two (2) chairs will be provided for an additional \$5. Each artist will be allotted one 8' x 6' space which HFV staff will clearly mark for set up.
8. Vendor/artist may arrive on site the day of the show to set up no earlier than 10:00AM. Hale Farm and Village is not open on the day of the event, so only the Gatehouse Visitor Center is open for the Cabin Fever Market. Booths must be ready for the show to open by 11:30AM.
9. Vendor/artist tables will be inside the Gatehouse Visitor Center. Not all tables will be provided with electricity. Spaces will be assigned in advance of vendor/artist arrival and the Hale Farm and Village staff will direct you to your table.
10. Only The MarketPlace at Hale Farm and Village and the Gatehouse Visitors Center will be open during the event. Vendor/artist and/or guests cannot access the rest of our museum and property.
11. Light beverages and snacks will be available for purchase.
12. A copy of the event flyer will be provided when accepted into the show for you to forward via email or to print out hard copies. Your partnership in marketing this event will help make it a success for everyone. Please follow, share, and tag HFV appropriately on social media.

CONDITIONS OF THE SHOW

This application and agreement covers the 2026 Cabin Fever Market. Our Western Reserve Historical Society membership is currently around 2,200 households. They will be invited in the Western Reserve Historical Society e-newsletter. Hale Farm and Village will also promote this event via ads, website and social media. Artists/vendors are expected to promote the event through their marketing outlets, as well. Hale Farm & Village will provide approved content.
