THE LIBRARY/ARCHIVES HOLD MILLIONS OF ITEMS INCLUDING BOOKS, PHOTOGRAPHS, MANUSCRIPTS AND DOCUMENTS, MAKING IT A PREMIER RESEARCH INSTITUTE FOR SCHOLARS, THE GENERAL PUBLIC, AND GENEALOGISTS. HIGHLIGHTS OF THE COLLECTION INCLUDE CIVIL WAR MATERIALS, VARIOUS ETHNIC AND COMMUNITY COLLECTIONS SUCH AS THOSE OF THE AFRICAN-AMERICAN, JEWISH, ITALIAN AND IRISH HISTORIES OF THE REGION, AND EXTENSIVE BUSINESS, INDUSTRIAL, PHILANTHROPIC, ENTREPRENEURIAL AND POLITICAL RECORDS.
